**RULES FOR CLOSED BIDDING**

1. Vehicles may be started and test drove on the District compound only with District supervision. Call 530-533-6038 to schedule.
2. All bids must meet or exceed the minimum bid amount listed for each vehicle in order to be considered.
3. All bids must be submitted on the appropriate District form, must include bid price, signature, name, address, and phone number where you can be reached during the day. The bids need to be enclosed in a sealed envelope, accompanied by a check in the amount of 10% of the bid amount made payable to the District as security for the completion of the purchase and sale, and submitted to the District office located at 5117 Larkin Road, Oroville, CA.
4. All bids must be received at the District Office no later than Tuesday, October 7, 2025, by 4:25 P.M. **NO EXCEPTIONS**
5. All bids will remain sealed until the Board Meeting of October 8, 2025. All sealed bids will be opened during the time of the October 8, 2025, Board meeting by the District's Administrative Manager and award the highest bidder of each vehicle. The highest bidder will be notified the morning of October 9, 2025, and will be required to make arrangements with the District to complete the transaction and deliver full cash payment within 24 hours of notification.
6. Only "In-Full" Cash payments will be accepted.
7. If failure to make arrangements or failure to pay cash, the next highest bidder will be notified and awarded the vehicle under the same criteria and bid security shall be forfeited to the District.
